### 4. FIRST AID MEASURES

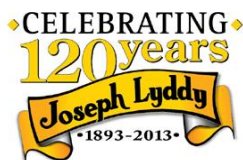

### 6. ACCIDENTAL RELEASE MEASURES

#### SMALL SPILLS

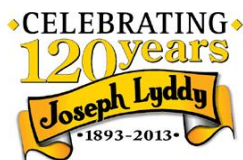
